

# **Referral Program Terms and Conditions**

DrimTel reserves the right to change this document at any time and notify you by posting an updated version on our website. The amended document will apply between us whether or not we have given you specific notice of any change. We encourage you to review this document periodically because it may change from time to time.

### 1. Duration of Promotion

The DrimTel 'Refer a Friend' promotion is an ongoing promotion until withdrawn ('Promotion Period') for DrimTel customers who:

- a. meet the eligibility criteria outlined in clause 2 below; and
- b. refer a friend who meets the eligibility criteria outlined in clause 3; and
- c. comply with the Terms and Conditions of this promotion.

## 2. Your Eligibility

To be eligible to refer a friend and participate in the promotion you must be a current DrimTel customer. Agents, including resellers, affiliates and business partners, of DrimTel and its Related Bodies Corporate (as defined in the Corporations Act 2011 (Cth)) are not eligible for this Promotion.

# 3. Eligible Referrals

The referred person must:

- a. not be an existing customer of DrimTel; and
- b. be referred by a person that meets the eligibility criteria in clause 2 above; and
- c. sign up to receive a DrimTel service and provide DrimTel with their referrer's mobile number during checkout either over the phone or on the DrimTel website; and
- d. have activated their DrimTel services.

Each person meeting the requirements specified in (a) to (d) above will be an 'Eligible Referral'.

## 4. Successful Referral

A referral will be a Successful Referral when the criteria outlined in clause 2 (regarding Your Eligibility) and clause 3 (Eligible Referrals) has been met in full. All Successful Referrals will be eligible to receive the Promotion Offer.

#### 5. Promotion Offer

During the Promotion Period, for each Successful Residential Referral, DrimTel will:

- a. credit \$10 to the referring person's existing DrimTel account when the referred person pays their first invoice; and
- b. from time to time, DrimTel may offer a greater credit than the normal \$10 to the referring person as part of a "campaign". This offer is strictly available during the time of the standalone campaign period and all the remaining terms and conditions apply.

DrimTel may, from time to time and in its sole discretion, replace the credits to the referring persons DrimTel account with a different credit amount provided always that the amount credited to the referring person's DrimTel account is no less than the credits specified in the Promotion Offer.

#### 6. Other Terms and Conditions

- The Promotion Offer and Alternative Offer are not exchangeable or redeemable for cash, credit or any other gift.
  - DrimTel reserves the rights to change, suspend or discontinue all or any part of this promotion, at
    its discretion. DrimTel will endeavour to, but is not obliged to, provide reasonable notice of any
    change, suspension or discontinuance by updating this page at least 30 days before the change,
    suspension or discontinuance.
  - Referrer will be entitled to receive the Promotion Offer for each Successful Referral up to a maximum of 20 times for the duration of the promotion.
